Sunken Garden Improvements by Maureen Miller



The Sunken Garden was originally a water feature on the golf course that was part of the Mount Plymouth Hotel/Country Club. The Mount Plymouth Land Owners League and East Lake Historical Society asked Lake County Parks and Trails to help preserve the ruins of this site which is located on Lake County property.

These are the improvements that have been made. Lake County has assigned this address to the property: 31100 Grassy Sprain Ave., Sorrento 32776. They have completed setting the property boundaries and installing fences. They have cleaned up the trash and illegal dumps from the site. They have removed invasive plant material including bamboo within the project boundary. They are exposing and cleaning the rock garden areas. There are limited parking spaces just off Grassy Sprain Ave.

The Society is currently working with the Office of Parks and Trails to move a coquina fountain from its current location on Pine Valley to Sunken Garden. We also hope to see signage added to Sunken Garden telling its history.

Thank you for renewing your membership and we look forward to hearing from you as we continue working together making our Society the best.

This September will be the beginning of our 15th year as the East Lake Historical Society. This is possible only because of you. Your membership is the heart of the Society and we have grown and continue to grow because of your support.
