9-2023 thru 8-2024 Nominations & Election Information

1. A member must serve on the Board of Directors for at least two years before accepting a nomination for an officer position.
2. A Member nominated for an officer position will be considered for a director position as well. This is done to not limit the candidate's opportunity to serve the Society.
3. Any Board of Director's position with only one candidate shall appear on the ballot as running unopposed.
4. Any member of the Society may be nominated to serve on the Board of Directors in any available position they are qualified for.
5. If an Officer or Director's current term is not up they can be nominated to serve any position they are eligible for.
6. Scott Amey has served 1 one year term as President and is eligible to be nominated for any position
7. Maggie Fisher has served 1 one year term as Vice President and is eligible to be nominated for any position.
8. Jacci Schwartz has served 2 two year terms as Treasurer and can be nominated for any position except Treasurer.
9. Maureen Miller has served as the Immediate Past President this past year and is eligible to be nominated for any position.
10. Shirley Grantham has served 1 two year term as Director and can be nominated for any position.
11. Katherine de Jongh was elected to serve an interim position for one year and can be nominated for a Director's position.
